




**Sub: SSA – Release of 1st installment of fund to the National Commission for Protection of Child Rights (NCPCR) for implementing the activities of the RTE Cell during the year 2014-15 (Plan)-regarding.**

Sir,

The Secretary (SE&L), MHRD has approved an amount of Rs. 500 lakh for RTE Division of NCPCR for the year 2014-15.

2. I am directed to convey sanction of the President for release of **Rs.1,22,57,000/- (Rupees One crore twenty two lakh fifty seven thousand only)** as 1<sup>st</sup> installment of funds after adjusting the unspent balance of 2013-14 for implementing the various activities of RTE Cell of National Commission for Protection of Child Rights (NCPCR) during 2014-15 to NCPCR, 5<sup>th</sup> Floor, Chanderlok Building, 36, Janpath, New Delhi-110001. The fund is of recurring in nature.

3. The grant is subject to the following terms & conditions:

- a. NCPCR will maintain a separate account for utilization of the amount sanctioned by the Government of India towards implementing the activities of the RTE Cell and will submit audited statement of accounts and utilization certificate in accordance with the terms of the contract. The accounts so maintained shall be open to audit by the Comptroller and Auditor General of India or by any authority deputed by him for the purpose as per rules.
- b. No part of the amount sanctioned by the Government of India shall be utilized for any purpose other than those approved by the Ministry.
- c. It shall be drawn during the current financial year before March 31, 2015 and shall be utilized within a reasonable period from the date of drawl.
- d. Equipments and materials purchased with the funds provided by the Government of India shall be the property of Government of India and marked accordingly. An inventory of such equipments and materials shall be made available to the Government of India upon termination or expiration of the contract and such

equipments and materials shall be disposed off in accordance with Government of India instructions.

- e. The NCPCR shall keep the Government of India informed of the progress of the work both physical and financial once every quarter.
  - f. The account of all grantee institutions shall be open to inspection by the sanctioning authority and audit, both by the Comptroller and Auditor General of India under the provision of CAG (DPC) Act, 1971 and Internal Audit by the Principal Accounts Office of this Department, whenever the institution is called upon to do so.
4. The NCPCR will submit annual detailed progress report of the project within one month from the close of the financial year. An annual audited statement of accounts along with a certificate of utilization of the grant for the approved objective duly signed by Chartered Accountant and Authorized Signatory of the NCPCR in original will be submitted within nine months from the close of the financial year.
5. The amount sanctioned will be drawn by the Drawing and Disbursing Officer (Grants), Ministry of Human Resource Development, Department of School Education & Literacy, Government of India, New Delhi on a Grant-in-Aid Bill for disbursement to the NCPCR-RTE, 5th Floor, Chanderlok Building, 36, Janpath, New Delhi 110001 in their Saving Bank Account No.31408202176, MICR Code 110002017 at the State Bank of India, Chanderlok Building (1<sup>st</sup> Floor), 36 Janpath, New Delhi - 110001. The payment should be made through electronic mode in favour of NCPCR-RTE as per enclosed Authorization letter.
6. The interest earned during the year will be refunded to the Ministry.
7. The expenditure will be debitable to Demand No. 59 Department of School Education & Literacy - Major Head - 2202 - General Education, 01 - Elementary Education - 111 - Sarva Shiksha Abhiyan -05- General Component, 05.00 SSA (GBS) - 05.00.31 - Grant-in-Aid General - 2014-15 (Plan).
8. The pattern of assistance has been approved by Ministry of Finance. This sanction is being issued in conformity with the rules and regulations as approved by the Ministry of Finance.
9. This Sanction issued in exercise of the delegated powers in consultation with Integrated Finance Division vide their Dy. No. 4210/IFD dated 27.08.2014 and the funds have been certified by IF-II vide their Dy. No.842/2014/IF-II dated 28.08.2014.
