
Recommendation by me:

- Long pending files should be forwarded to the state commission while states having no stste commission should be given top priority and disposed off as early as possible. Alternatively a committee could be formed.
 - The commission should exercise its right to summon the concerned authority if there is inordinate delay in receiving ATR's after due reminders have been sent.
 - While analysing files, I observed that even if the commission has received an ATR on a certain date, the copy of that ATR reaches the complaints section after few days which leads to more delay.
 - I analysed that if an ATR is not received on it's due date, the reminders are sent after more than a month and some times no reminders are sent. So i recommend that NCPCR should look in this matter and act accordingly.

- The Complaint Management System(CMS) should be regularly updated with the current status of the files.

CONCLUSION

The quality of lifestyle and personality of children will determine the kind of destiny a nation will have. NCPCR with it's continuous efforts ensures that each child born in the vast and complex country gets the best start in life. The commission with it's effective working ensures that all laws policies and programmes are in consonance with the child rights.
