INTERNSHIP REPORT

My internship began on 8.11.2012 and as of today, 7.12.2012, I have completed four full weeks of internship with the National Commission for Protection of Child Rights. As a first semester student of law, it has been an immense learning experience for me as NCPCR taught me how the law and the bureaucracy works to protect the rights of children and to ensure that justice is delivered to them.

During the course of these four weeks, I did a diverse array of work.

I was involved with the Complaints Department and the Operations Section.

COMPLAINTS DEPARTMENT:

My work for the complaints department involved reading, analyzing and tabulating cases dealt with and closed by NCPCR. I worked with child labour cases making me aware of how widespread the problem actually is and how little people are aware of or care about the rights of children who can't speak or fight for themselves. I feel NCPCR is their aegis, it provides them with a chance to voice their grievances. One thing that I liked about NCPCR is that it takes suo moto cognizance of complaints/ incidents involving violation of child rights and this is an excellent way of reaching out to those children/families that are not aware of how to go about in their search for justice.

I was also involved in a Parliament question involving the Commission. I tabulated data for the same. I got an idea of the number and kinds of child right violations that have taken place in the country over the past year and what kind of action NCPCR has taken to deal with the same.

I also helped in compiling the success stories which were to be a part of the annual report of NCPCR for 2011-12. It gave me an idea of how the entire process is carried out, right from the admission of the complaint, to the actions taken by NCPCR, who the matters are referred to, what kinds of steps are taken and what is done to ensure that a child's rights are protected and in case of a violation, the appropriate steps are taken to ensure that the child does not suffer.

OPERATIONS DEPARTMENT

My work with the operations department was very interesting and the most enjoyable. In the first few days of my internship I accompanied the consultants on their inspections of various children's homes in New Delhi as per the order of the Supreme Court in Amardeep Malik vs Govt. of NCT of Delhi. The next step of my work was to compile the reports of all these inspections along with the team's observations and recommendations. The thoroughness with which the inspection

reports were compiled was an example of how seriously the issue of child rights and especially of those children who don't have families to look after them are taken.

I was also involved in preparing the RTE department's bi-monthly report to MWCD. It gave me an insight into how one of the most ambitious measures to give children their basic right-the Right to Education is carried out by the government. The kind of projects and legislations that the government enacts to ensure that all children are provided with basic education made me realize how expansive the RTE actually is.

I also attended the Vatsalya Mela held by the Commission at Delhi Haat, interacting with students, telling them about their right to complain about and stop Corpora! Punishment made me feel that I had atleast, made a tiny change.

It was an honour for me to get this opportunity to intern at the Commission.
