# AGENDA ITEMS PROPOSED BY LEGAL DIVISION:

Agenda Item No.1: CiSS link on Bal Swaraj Portal (for tracking children who are living in street situations):

The Hon'ble Supreme Court in SMWP (C) No.6/2021 In Re children in street situations has taken *suo-moto* cognizance on the issues pertaining to children in street situations. The Hon'ble Supreme Court while taking up this matter has discussed the SOP 2.0 on children in street situations issued by NCPCR and has directed the States/UTs to implement the SOP 2.0 of NCPCR for rescue and rehabilitation of children in street situations.

The Hon'ble Supreme Court in its order dated 15.11.2021 has given the following directions".

- (i) The District Magistrates/ District Collectors are to take steps in accordance with SOP 2.0 that has been formulated by the NCPCR.
- (ii) The Secretary, Department of Women and Child Welfare of each State shall be the nodal officer to ensure that all the District Magistrates/ District Collectors take prompt action for implementation of SOP 2.0 formulated by the NCPCR.
- (iii) The process has to start with immediate action being taken by the authorities for identification of CiSS and thereafter, providing the required information NCPCR for the later stages as well.
- (iv) The State Governments/Union Territories are directed to promptly attend meetings that are held by NCPCR and offer their suggestions, apart from voicing their concerns, if any, in implementation of the SOP 2.0.

Further, the Hon'ble Supreme Court in its order dated 13.12.2021 has directed the State Governments/Union Territories to take immediate

delay and upload the required information on the Bal Swaraj - CiSS portal of the NCPCR. The Hon'ble Supreme Court has further stated that identification of children and registration of these children at Stage-1 of the NCPCR's Baal Swaraj-CiSS Portal is crucial. Therefore, the States/UTs have to upload the data of rescued street children on the Bal Swaraj Portal-CiSS of NCPCR.

There are six stages in the portal which have to be filled by the District Child Protection Unit and State Child Protection Society-

- Stage 1 asks for personal basic details of the child like name, age, address etc.
- (ii) Stage 2 asks for filling up the social investigation report of the child.
- (iii) Stage 3 is the form of individual child care plan wherein it becomes clear that where the child is being placed, recommendation of Child Welfare Committee, sponsorship benefits etc.
- (iv) Stage 4 has been given to upload the Child Welfare Committee order.
- (v) Stage 5, total 34 Government implemented schemes/ benefits have been listed out from which the DCPU can select the benefit of schemes being given to the child in this stage.
- (vi) Stage 6 is for uploading follow-up forms of children. Where the child has been recommended for follow-up, whether in child care institution or in non-institutional care, the follow-up is done by the person assigned by the Child Welfare Committee. So in this stage, if there are any follow-up forms filled by the officer conducting follow-ups of the child, then those forms have to be uploaded.

In compliance of the Hon'ble Supreme Court orders, the states/UTs are uploading data on this portal. The State/UT-wise data received regarding children who are in street situations as on 09.12.2021 on Bal Swaraj portal-CiSS is given at *Annexure-I*-

# Agenda Item No.2: An appeal to be filed by NCPCR before the Hon'ble Supreme Court against an Allahabad High Court verdict on child sexual assault:

A recent judgement dated 18.11.2021 has been pronounced by the Hon'ble High Court at Allahabad in Criminal Appeal No.5415 of 2018 in the matter of Sonu Kushwaha V. State of UP before the Hon'ble High Court at Allahabad. In the said judgement, the Hon'ble High Court has commuted the sentence of the accused from 10 years to seven years citing the reasons that the accused has committed an offence under Penetrative Sexual Assault (Section 3 and 4) and not Aggravated Penetrative Sexual Assault (Section 5 and 6). It is clear from the facts of the case that there was penetrative sexual assault by the accused and that the offence falls under the Aggravated Penetrative Sexual Assault. This judgement has been observed by the Commission to be not as per the letter and spirit of the POCSO Act, 2012. The commutation of sentence of the accused in the present case, wherein the accused has been convicted for committing a serious violation of penetrating his penis in the mouth of the child, is observed by the Commission to be prejudicial to the justice delivered to the victim in this case and the Commission feels that such necessary steps in the matter to file an urgent appeal against the aforesaid Judgement of Hon'ble High Court must be taken.

Further, the Ministry of Women and Child Development vide its letter dated 26.11.2021 has requested the Commission for taking up filing of an appeal in the Hon'ble Supreme Court with regard to the above court order of Allahabad High Court and protect the interest of Government of India.

In view of the directions of MWCD and the rights of the minor victim, an appeal may be filed before the Hon'ble Supreme Court challenging the order of the Hon'ble Allahabad High Court.
