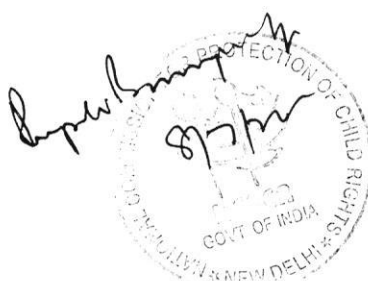
The meeting commenced with a welcome note and brief introductory remarks by the Chairperson.
