Subject: Filling up of the post of Principal Research & Technical Expert (Education) at the National Commission for Protection of Child Rights, New Delhi- regarding.

The National Commission for Protection of Child Rights, a Statutory Body of the Ministry of Women and Child Development, New Delhi, invites applications from eligible candidates for the post of Principal Research & Technical Expert (Education) as per the following details-

1. NAME OF THE POSITION- Principal Research & Technical Expert (Education)

Under the overall guidance and direction of the Chairperson and Member Secretary, NCPCR, the position requires to manage the activities undertaken in the Commission related to education of children and their right to education. The expert shall provide technical guidance and operational support in all stages of conducting programme activities carried out by the Commission to promote rights of all children including those who are marginalized, excluded and disadvantaged and in difficult circumstances.

2. ELIGIBILITYQUALIFICATION AND EXPERIENCE-

Essential-

- i) Ph.D. in Education or Elementary Education or any other concerned/relevant/allied subject from a recognized Indian University.
- ii) A minimum of 8-10 years of experience working with children and/or in the field of education/ elementary education/ child rights with strong research background. Out of this, atleast five years of experience must be of working in a Government Department, in a Government Autonomous or Statutory body.
- iii) The candidate must have experience in guiding research projects, drafting project proposals and policy documents; and carrying-out programme activities.

Desirable-

Publications in field of Education and/or issues related to child rights.

3. PERIOD OF ENGAGEMENT, AGE AND REMUNERATION

- i) The engagement would be initially for period of one-year which shall be extendable further subject to availability of budget and requirement.
- ii) The upper age limit to apply for the position is 45 years.
- iii) The monthly remuneration shall be in the range of Rs. 1,25,000/- to Rs. 1,75,000/- (Consolidated) as per the qualification and experience. The remuneration is consolidated amount with no other pay or perks.

4. TERMS & CONDITIONS:

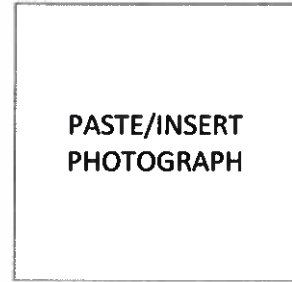
- i) The above position is to be filled up purely on temporary basis and does not give the candidate any guaranteed claim over the permanent position in future, if any,
- ii) The selected candidate shall be eligible for one day leave per month as per the NCPCR's Leave Policy,
- iii) The Expert will be provided remuneration as agreed to subject to deduction of TDS as per rules applicable from time to time;
- iv) TA/DA will be paid for the outstation official visits undertaken as per the NCPCR norms,
- v) The continuance of position will be subject to availability of budget and requirement. The assignment can be terminated without giving any reason on one month's notice or with payment of one-month salary in lieu thereof. The selected candidate may be free from the position with an advance notice of one month for rendering resignation or by making payment of one month's remuneration for it,
- vi) NCPCR reserves the right to cancel or withdraw the advertisement without assigning any reason.
