Table Agenda Item No.1: Review Meetings on Prevention of Drugs and Substance Abuse among Children in 25 Districts:

For prevention of children from drugs and substance abuse and illicit trafficking, a Joint Action Plan (JAP) on "**Prevention of Drugs and Substance Abuse Among Children and Illicit Trafficking**" was developed by the National Commission for Protection of Child Rights (NCPCR) in collaboration with Narcotics Control Bureau (NCB), on the basis of deliberation with concerned Ministries and Institutions. The JAP was released on 9th February, 2021.

District-wise Review Meetings of all the districts on implementation of Joint Action Plan (JAP) are being held virtually by NCPCR. It is pertinent to mention here that orientation of district officials and concerned stakeholders on prevention of drugs and substance abuse among children and illicit trafficking is important for better compliance of indicators of JAP.

Keeping in view of the above, it is proposed to conduct orientation-cum-review meetings in 25 Districts in second quarter of financial year-2023-24. A list of 25 Districts shall be submitted on file for approval of Chairperson, NCPCR.
